Joseph Stoddard will be demonstrating in our general meeting, Thursday, May 9, 2019 and holding a 2-day workshop on Friday & Saturday, May 11-12, from 9-4.

Joseph paints and sketches architecture, landscapes and urban subjects, using pen and ink with loose applications of color in a unique, impressionistic style. In addition to traditional paintings, he also produces collages with drawings, sketches, compositional studies and notes mounted to cradled hardboard panels. His work is all about process.

He has produced paintings for a number of Pasadena events, including the Bungalow Heaven Annual Tour, the Colorado Street Bridge Party, the Pasadena Showcase House of Design, the California Art Club Artists for Architecture Painting Project, the Pasadena Symphony and the Pasadena Pops Orchestra. His work has been featured in the The Art of Watercolor, a French art magazine as well as Studios magazine, and

Watercolor Artist magazine. His studio was featured in The Man Cave Book.

His paintings have also been on the covers of a variety of publications including Westways Magazine, Pasadena Magazine, a book series published by the Historical Society of Southern California, and the Lost and Found Series by Many Moons Press. In 2001 a book of his sketches entitled Pasadena Sketchbook was published. The second edition was published in October of 2008. A collection of sketches of the University of Redlands entitled Redlands Sketchbook was published in 2007. Walter Foster Publishing published Expressive Color, a painting instruction book in August of 2008. He just completed a new book for Quarto Publishing entitled Expressive Painting and is preparing a series of new paintings for the third edition of Pasadena Sketchbook. ## 2019 Workshops

Workshops are held 1-3 days from 9am - 4pm with a break in the middle for lunch. There is a refrigerator for a packed lunch, and shops and restaurants a short drive away. Remaining workshops this year:

#### **Workshop Policy:**

The workshop fee includes a 10% non-refundable cancellation fee if a cancellation is made more than 30 days prior to the workshop. A 50% non-refundable fee if cancellation is made between 30 or 7 days. No refund will be made for a NO SHOW or a cancellation with less than 7 days of notice prior to the workshop. The workshop may be cancelled at the discretion of the Workshop Chair and the President if any of the following occur: there are less than 10 participants, the workshop is not at a financial breakeven point, or the demonstrator or location cancels. In this case, FULL refunds will be given. If for any reason your check or credit card payment is rejected by your bank, VWS will ask you for a reimbursement if any fine or charge is assessed by your bank to VWS. After two incidents, membership will be revoked. Enroll in workshops by bringing your check to any meeting, or enroll online at http://valleywatercolorsociety.org/events.
