## Ruth Ellen Hoag Demonstrator, Thursday March 10th

Ruth Ellen Hoag graduated from Manhattan School of Music with a French horn major. She had a thirty-year music career. While living in Japan, she found painting as a new passion. Nearly all her work is figurative, experimenting with various approaches and painting styles, while to capture a sense of movement with the characters or the space they occupy.

Her paintings have been awarded in many national and international exhibitions: including medaling in American Watercolor Society, and winning top honors at San Diego Watercolor Society's International Exhibition. She has earned Signature status from National Watercolor Society, the San Diego Watercolor Society, California Watercolor Association and Watercolor West.

Ruth Ellen Hoag has juried exhibitions, been invited to give demonstrations and workshops in several western states and as far south as Rio de Janeiro, Brazil.

A number of books and magazines have published her work including Watercolor Artist and Palette Magazine. A founding member of Santa Barbara Studio Artists studio and Whistle Stop Art Studios in downtown Santa Barbara which hosts year round studio tours.

Ruth's art is based on the figurative genre. Observing everyday encounters, events and endeavors, finding insights into how to portray the people that she draws and paints. While figures are the constant, what changes is the degree of realism and abstraction design.

Much of her recent work has been on a large format with a plethora of figures in invented settings. The process of creating the scene, involves finding opportunities to capture movement for the characters and what they are doing, but also to create animated surfaces of one kind or another. She wants the character to be important to a larger sphere of pending activity and hopes the viewer will also become engaged.

#### ALL JURIED MEMBER SHOW

The big Moment , <u>2016 Juried Members Show</u> is almost here! Don't miss out showing your work and the opportunity to win hundreds of dollars in cash prizes with top award being \$400. **Last call for entries is at Midnight March 9th** and take-in is just around the corner. Accepted artwork take-in is **Sunday April 3**, **between noon and 2pm** at the Valley Arts & Cultural Center, 18312 Oxnard Street, Tarzana, CA.

All accepted artist will be informed by email. Included in that email will be labels for identification of art work and a 10 item form for artwork to be sold in the Gift Shop. Labels and gift shop form must be filled out and brought with the art work on "Take-In" April 3.

The exhibit committee can not stress enough the importance of following the size and framing guidelines in the prospectus. The frame size requirements are the total exterior size including frame and mat. No colored mats, white or a neutral (near white) while be excepted. Paintings must be framed in a gallery quality frame, Plexiglas only No Glass and framing wire hanger positioned two inches from the top of the frame. Artwork will be rejected if it does not compile with the requirements

All artwork sold must remain in the exhibit and can not be removed until the close of the show. All exhibiting artists are required to sit the gallery for one three hour shift. Shifts are 11 am to 2 pm, or 2 pm to 5pm sign-up for this commitment is April 3 at "Take-In". If the artist can not complete this responsibility it is your duty to find a replacement

Our juror artist ,Linda Doll, is the San Diego based teacher and award winning artist whose work has won international recognition. She is listed in the Who's Who of American Art

and is a past-president and life member of the National Watercolor Society and a past board member and juror of the American Watercolor Society.

Phyllis Doyon, Friday November 11 - I have always loved to work with watercolor and water media, enjoying the vibrant colors and flow of the paint. Committing to bold color early in the painting keeps the work clean and transparent. This is what gives watercolor its sparkle and life.

### **Workshop Policy**

- 1.) The full amount for each workshop is required when you sign up. Your space will not be guaranteed without payment by check or cash.
- 2.) The workshop fee includes a 25% non-refundable cancellation fee (except as noted in #4 below) if a cancellation is made less than 7 days prior to the workshop, unless the spot is filled. Any refund given will be minus the 25% cancellation fee.
- 3.) No refund will be made for a NO SHOW or a cancellation with less than 2 days of prior notice, unless the spot is filled.
- 4.) For workshops that are 3 days or longer, we require a deposit of 50% with sign up. These workshops are with artists from out-of town and special financial arrangements have to be made for their visits. The full amount is due 60 days prior to the workshop. A cancellation fee of 50% (instead) of 25%) applies.
- 5.) A workshop may be cancelled at the discretion of the Workshop Chair and the President if any of the following occur: There are less than 10 participants, the workshop is not at a financial breakeven point, or the demonstrator or location cancels. In this case, full refunds will be given.
- 6.) Payment by check for individual workshops must have a current date and should not be post-dated. Checks for multiple workshops and cash will be promptly deposited.
