Debbie earned her Signature Membership in the Watercolor West organization and was honored to be included in the Northlight Publishers book, 'Splash 15', featuring the best 100 watercolor artists of the year.





Workshop Policy:

The workshop fee includes a 10% non-refundable cancellation fee if a cancellation is made more than 30 days prior to the workshop. A 50% non-refundable fee if cancellation is made between 30 or 7 days. No refund will be made for a NO SHOW or a cancellation with less than 7 days of notice prior to the workshop. The workshop may be cancelled at the discretion of the Workshop Chair and the President if any of the following occur: there are less than 10 participants, the workshop is not at a financial breakeven point, or the demonstrator or location cancels. In this case, FULL refunds will be given. If for any reason your check or credit card payment is rejected by your bank, VWS will ask you for a reimbursement if any fine or charge is assessed by your bank to VWS. After two incidents, membership will be revoked. Enroll in workshops by bringing your check to any meeting, or enroll online at http://valleywatercolorsociety.org/events. Just select the desired workshop and scroll down to the "Register Now" button.
